DELL TELEPHONE COOPERATIVE EDUCATION FOUNDATION AWARDS CONTINUING EDUCATION SCHOLARSHIPS



The Education Foundation of Dell Telephone Cooperative recently awarded over \$13,000 in Continuing Education Scholarships for the 2011-2012 academic year. Full-Time Student Scholarships valued at \$1,500 per semester were awarded to Alejandra Covarrubias-New Mexico State University, Mitchell Goss-New Mexico State University, and Alejandro Silvia-El Paso Community College. These students represent the Dell City, Texas and Timberon, New Mexico Exchanges of Cooperative's service area.

Part-Time Student Scholarships valued at \$1,000 per semester were awarded to Donovan Guillen-El Paso Community College and Mecca Hickox-Howard College; students represent the Dell City, Texas and Dell City, New Mexico Exchanges of the Cooperative's service area.

Established under the direction of the State Legislature, the Education Foundation has awarded over \$181,000.00 in scholarship funds to deserving students within our service area since 1996. The Education Foundation is funded by unclaimed capital credits. Under Texas state law, if all attempts to locate former members fail, the capital credits due to the former members escheats (is turned over) to the State of Texas. State law allows utility cooperatives, such as Dell Telephone, to establish non-profit foundations, to which a percentage of these "escheat" funds can be contributed and used to provide annual scholarships, rather than being turned over to the state.
